MULTI USE GAMES AREA

The establishment of the Jubilee Action Group which it is expected will eventually act as the umbrella group to assist with the establishment of a MUGA and possibly a Youth Shelter is now well on its way. The group will be formed as a Trust giving it a clear legal identity and will be made up of a number of Trustees who will act jointly on behalf of the Group. A small number of co-opted members will also be recruited to assist in managing the Groups affairs. The next Council Meeting will have an agenda item asking for a Parish Councillor nomination to act as one of the Trustees. The Trustee will not be a representative of the Parish Council but will be a full Trustee who will act along with the other Trustees in the interests of the Group itself and not on behalf of the Parish Council.
